## **CORRESPONDENCE AND NEW ISSUES**

Parish Paths. Signage. The Clerk and ward Councillor will contact the NLC officer for an inspection. One sign is missing.

NLC Transfer of grass cutting to parish council.2021 figures £2551 verges and paths £312.00. The parish councillors requested the Clerk obtain the necessary quotes for the work in 2021 only from the existing contractor as the standard has been high and there is no change from a local contractor.

Two co-options to the council exist. These vacancies can remain unfilled until the parish council meets again in the village hall. May 2021 maybe a possibility.

Potholes on the High Street.NLC have provided timescale for work to be carried out. Noted.

Trees village green, three quotes have been sought. Resolved the quote from Tapperell Trees be accepted in the sum of £1550 plus vat. An application has to be made to NLC due to the trees having a Tree Protection Order on them.

Draft budget 2021-2022 for precept purposes. A discussion followed on the figures presented. Resolved a precept of £5500 be set for the year.NLC to be advised accordingly.

Partnership funding £193 is allocated by NLC in addition to the precept.

East Riding Local Plan update. Noted.

Donation Eastoft PCC. Resolved £100 be paid.

Mower Service 2021.The clerk will obtain a quote and present at the March meeting.

Spring in Bloom. The clerk has submitted an application on the sum of £250 to NLC.Figures supplied by the gardening volunteers.
