D Sanderson attended, Parish Paths Officer, from North Lincolnshire Council re parish paths. This council is asked to enter into a parish paths partnership and use its own contractor. Footpaths 8 and 7 are the only concerns in the parish and North Lincolnshire Council talk to the landowners regarding any difficulties. Nearby parishes may wish to engage the same contractor. Cuts can then increase from 3 times a year to 4 or 5 cuts. NLC will pay 11p per metre.
